#### ➤ Attendee Overview

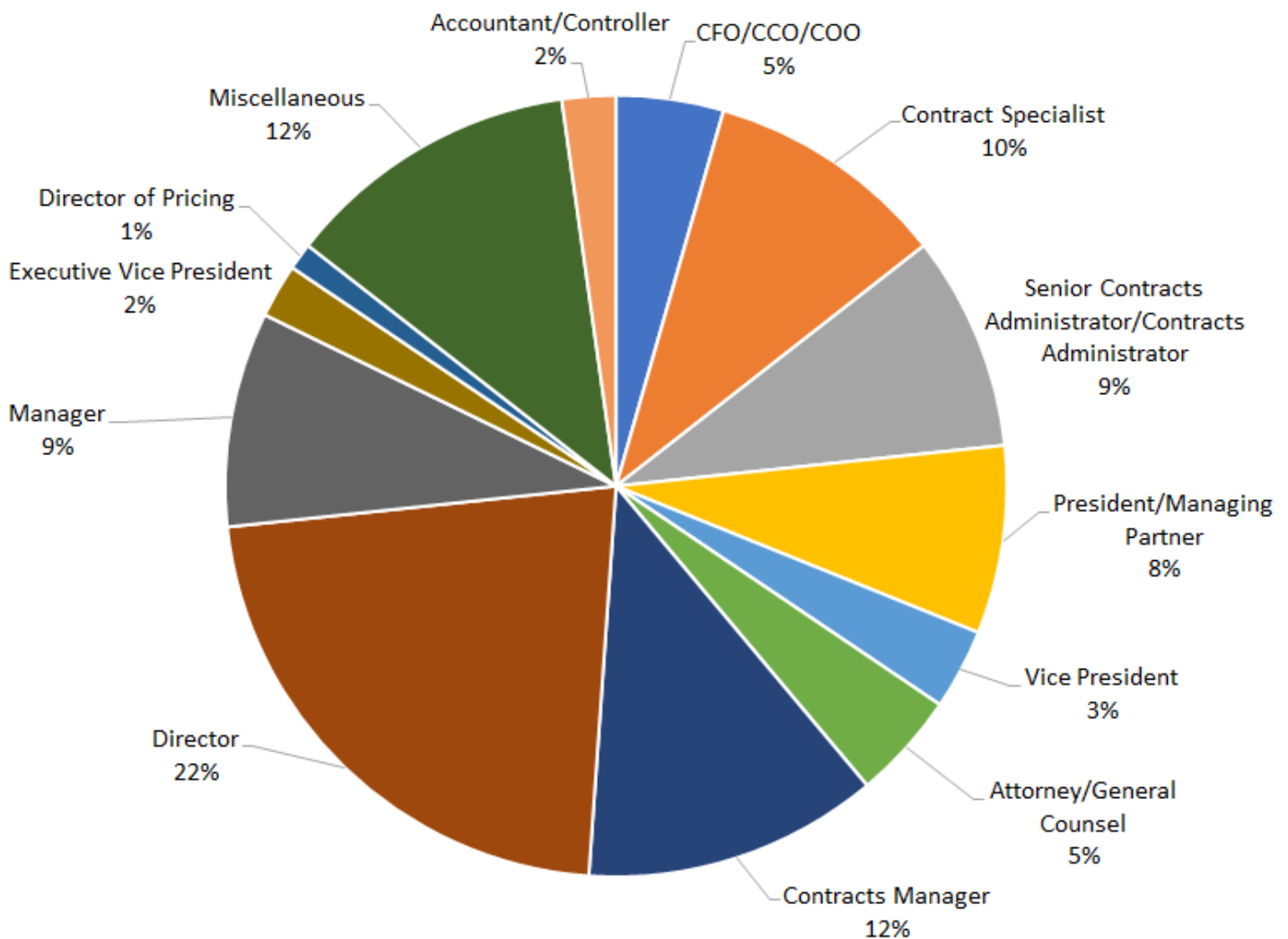
